

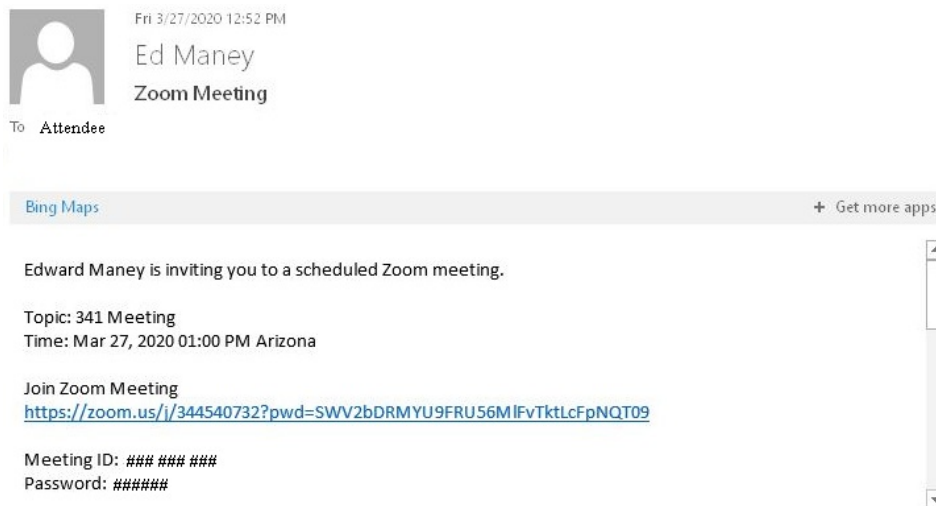
Zoom Section 341(a) Meetings of Creditors

Due to the closure of the 341 Meeting room, the Section 341(a) Meetings of Creditor will be conducted via video conference, using Zoom. Your attorney will provide you with Meetin ID and Meeting Password for your Meeting of Creditors or forward you an email link. The Zoom meetings can be accessed via computer (desktop or laptop), tablet or smart phone. You must have a valid identification and proof of your social security number available during your Meeting of Creditors. Failure to attend your Meeting of Creditors will result in the dismissal of your case.

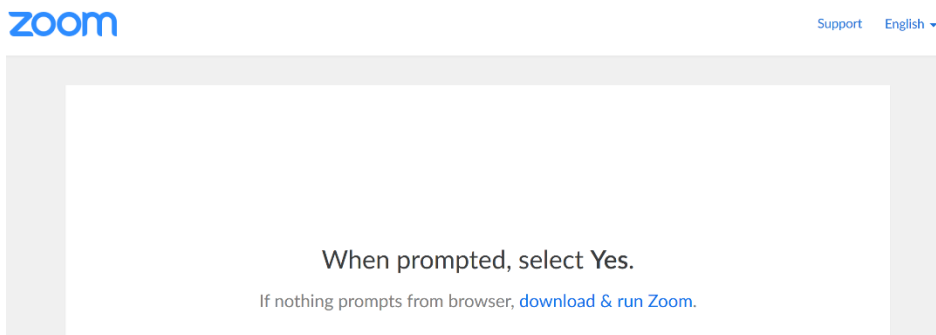
Using a Computer (Desktop or Laptop)

The laptop or desktop computer being used must have a webcam, microphone and speakers. If you do not have a microphone,

1. Click on the link from the email



- a. You will be taken to the Zoom page to auto download the Zoom software, if it does not automatically download, click the “download& run Zoom” link.





- b. Once the software is downloaded, Zoom will prompt you to enter your name to join the meeting. Enter your First and Last name and select “Join Meeting.”





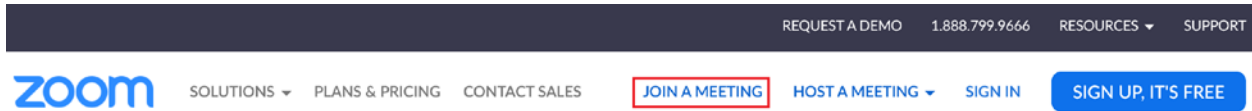

- e. While in the Waiting Room, you may test your audio connection by selecting, Test Audio.
 - f. Once your Meeting of Creditors has ended, the Trustee will place you back into the Waiting Room and you are free to leave the meeting.
2. If you do not have the email link, go to www.Zoom.us.
- a. Select “Join a Meeting” from the top of the page.



- b. Enter the Meeting ID and select join.

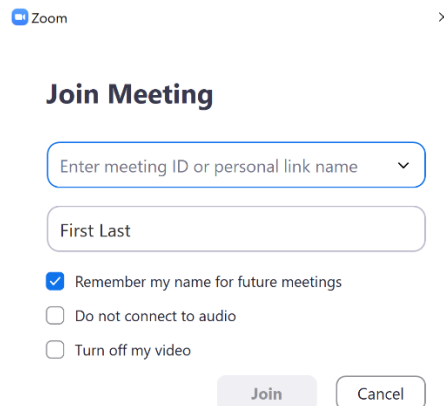
- d. Follow steps 1(c-f) from above.

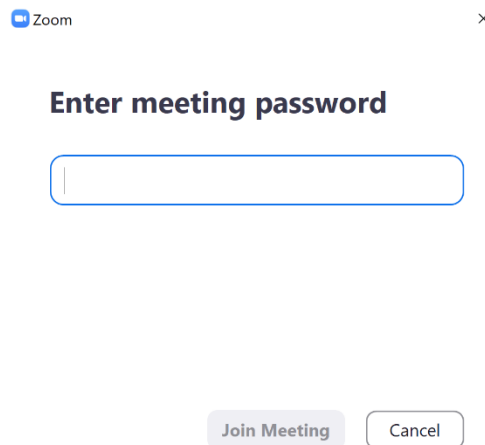
3. If you already have the Zoom software installed, open Zoom.

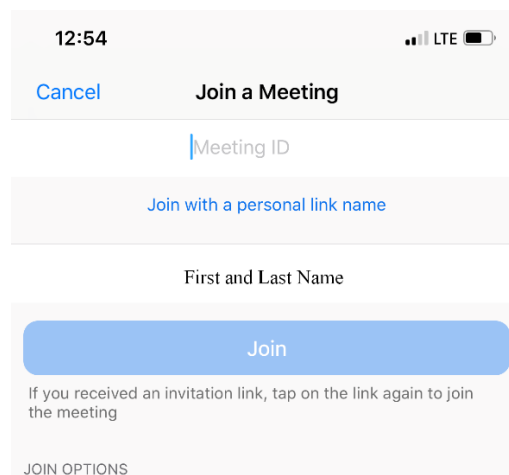
Tablet

The tablet being used must have a camera, microphone and speakers.

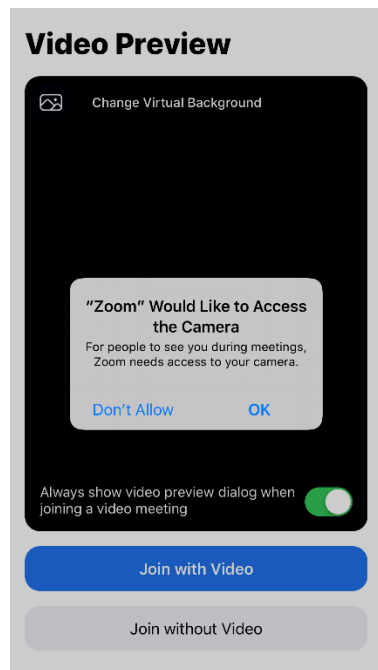
1. Download the Zoom app from the [Google Play Store](#) or [Apple Store](#)

- b. Enter the Meeting ID Number and your First and Last name under “Join with a personal link name.”

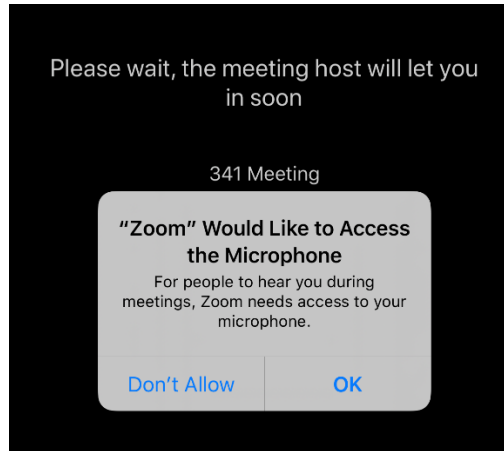


- c. A video preview will display, select “Join with Video.”

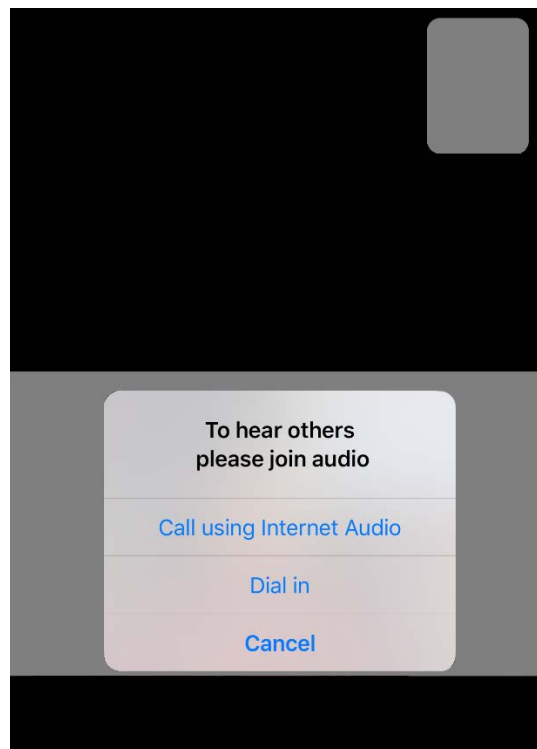

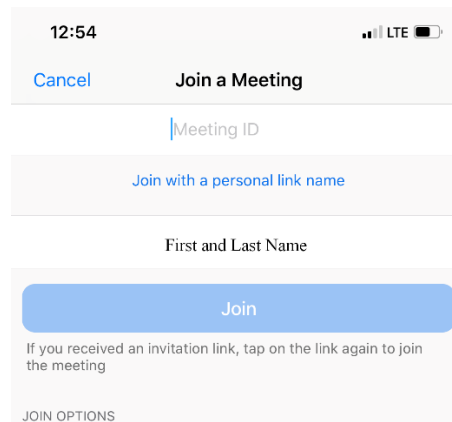
Smartphone

The smartphone being used must have a camera, microphone and speakers.

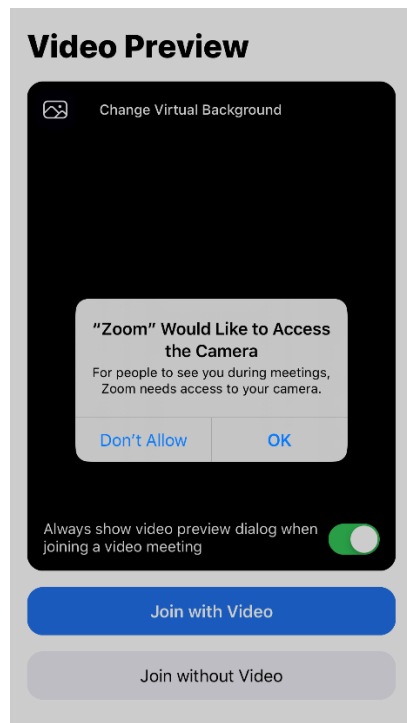
1. Download the Zoom app from the [Google Play Store](#) or [Apple Store](#)

- b. Enter the Meeting ID Number and your First and Last name under “Join with a personal link name.”

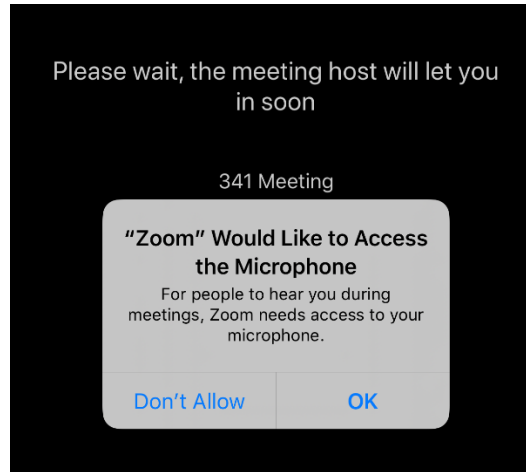


- c. A video preview will display, select “Join with Video.”

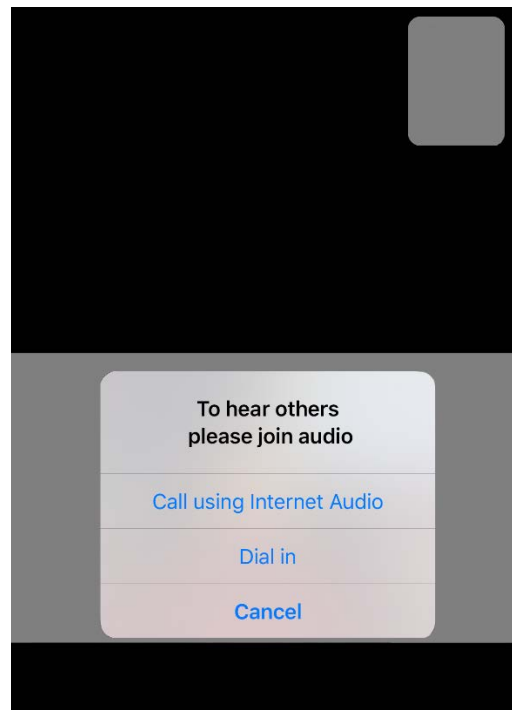
